Balance Computation Method: We use the daily balance method to calculate the interest on this account. This method applies a daily periodic rate to the principal in the account each day.

Transaction Limitations: You cannot make deposits to this account during a term (other than credited interest). You cannot withdraw principal from this account without our consent except on or after maturity. For accounts that automatically renew, there is a ten (10) day grace period after each renewal date during which withdrawals are permitted without penalty. Interest earned during one term that is not withdrawn during or immediately after that term is added to principal for the renewal term.
